Synopsis: Report results of interview and DNA collection for CHARLES NELS BUSCH, conducted on 04/22/2008.

Enclosure(s): Enclosed for Detroit, OCRA, is one (1) FD-302 Report regarding the 04/22/2008 interview of CHARLES NELS BUSCH.

Details: For the information of Detroit, OCRA, CHARLES NELS BUSCH was interviewed on 04/22/2008 at his part-time, apartment residence in New York City. BUSCH was at first reluctant to provide a DNA sample, but at the conclusion of the interview, and after consultation with his wife, he consented to the collection of his DNA. The buccal swab kit used to make this collection was forwarded to the Laboratory ECC under separate cover on 04/24/2008.

Detroit should note that BUSCH's primary contact information (full time residence) is as follows: [REDACTED]

[REDACTED] BUSCH was in North Carolina prior to this interview, which delayed the covering of this lead.

BUSCH was cooperative during his interview, but indicated his anxiety and apprehension towards any recall of his brother CHRIS BUSCH's suicide, and any involvement CHRIS could have had in captioned investigation. BUSCH requested that the following be executed should positive results be obtained with his DNA, and/or

any public announcement naming CHRIS BUSCH as the Oakland County Child Killer:

- 1) Direct notification to him and his wife prior to this announcement.
- 2) The utilization of Detroit Victim Witness personnel to the survivors of his brother, John Busch, who currently reside in Michigan.
- 3) Refraining from any public announcement specifically naming CHARLES BUSCH as a contributor of a family DNA profile.

As a guarantee of these conditions were crucial to the obtainment of BUSCH's sample, New York requests that Detroit coordinate this with New York, if at all necessary.

On April 22, 2008 (Tuesday), at approximately 3:10pm, CHARLES NELS BUSCH, a.k.a. Chuck Busch, White/Male, [REDACTED] (hereinafter "CHARLES"), was interviewed at his part-time residence located at [REDACTED] by Federal Bureau of Investigation (FBI) Special Agents Thomas P. MacDonald and Barbara A. Daly. CHARLES was advised of the identity of the interviewing Agents and that the interview pertained to a Michigan cold-case matter known as the "Oakland County Child Killing" investigation in which his brother, CHRIS BUSCH (hereinafter "CHRIS"), was a potential suspect. CHARLES provided the following information:

BACKGROUND INFORMATION

The Busch family consisted of four children, all boys. David and John were both older than CHARLES, and CHRIS was seven years younger. The family moved around quite frequently when the boys were young as CHARLES' father was an executive with General Motors. CHARLES is the only living member from his immediate family:

David, who CHARLES described as a homosexual and "sort of an activist", died of leukemia in England where he had lived for several years. David had no children.

John died approximately five years ago in Michigan of congestive heart failure and diabetes. CHARLES advised that John had struggled in his life with alcoholism but had stopped drinking at the time of his death. John has two children who are alive today, both living in Michigan. Brent Busch is John's adopted son, and he is currently believed to reside at [REDACTED]

[REDACTED] Scott Busch is John's biological son and is believed to reside at [REDACTED]

Scott Busch has a daughter named Samantha Busch. Samantha's mother is Elsie Busch, and according to CHARLES, Elsie and Scott are no longer together but remain friendly. CHARLES stated that it was "a little dysfunctional", but that Elsie is now involved with Brent Busch and Samantha lives with the two of them. CHARLES advised that both of John's children (Brent and Scott) have struggled with substance abuse and have in the past been in trouble with the law. CHARLES advised that his contact with them is mostly telephonic, and on a monthly basis.

CHARLES advised that CHRIS was born in Pontiac, Michigan and prior to the age of ten had lived in Rochester, New York, Short Hills, New Jersey and Germany (in that order). These were all family moves pertaining to their father's career at General Motors. By age ten CHRIS was living in Germany and attending the first grade. While their family was settled in Germany, both CHARLES and CHRIS attended a grade school and high school at a boarding school in Switzerland called Le Rosey. After his graduation from Le Rosey (completion of the twelfth grade) CHRIS stayed at Le Rosey as an instructor. CHRIS then returned to the United States and attended Wayne State University in Detroit for one year. CHRIS then transferred to a Culinary Institute in Midland, Michigan from which he eventually graduated. After this, CHRIS worked as a chef at a retirement community in the Detroit area for approximately one year. After this CHRIS, with the financial assistance of his father, opened his own restaurant in Alma, Michigan called "The Scotsman". During the time period CHRIS was operating this restaurant, which CHARLES advised was in CHRIS' mid to late twenties, CHRIS was arrested for molesting a boy in Birmingham, Michigan. This boy (the complainant or victim in the molestation case) had been mentored by CHRIS in the Big Brother Program, a program CHRIS had become involved in. CHARLES believes that CHRIS also knew this boy's mother, and that she possibly worked as a cashier at the Fishers Meat Market in Birmingham, Michigan. 7B-78

CHARLES advised that after CHRIS was indicted for this molestation case (mentioned above) he moved back in with his parents in Bloomfield Hills, Michigan. This was primarily due to the fact that his attorneys and psychiatrists were nearby. It was during this time that CHRIS committed suicide.

CHARLES described CHRIS overall as a "gregarious and happy guy", who physically was "big and heavy". CHARLES provided the following as hobbies for CHRIS: food, skiing and riding his motorcycle. CHARLES advised that CHRIS also struggled with problems associated with living overseas and returning to America, stating "it is hard to go back to your own country".

CHARLES advised that he had no recollection of CHRIS taking art classes, or of being particularly interested in drawing as a hobby. Both CHRIS and CHARLES took art classes at boarding school as part of the normal curriculum.

CHARLES had no recollection of CHRIS being involved in hunting, and advised that hunting was not something their father did or introduced to his sons. CHARLES had no knowledge of how or where CHRIS obtained the shotgun that was found in the bedroom where CHRIS killed himself, or of any ammunition he collected.

THE SUICIDE OF CHRIS BUSCH

CHARLES advised that he was present when CHRIS' body was found after he had killed himself. CHARLES stated that this was a very traumatic experience and he admittedly has blocked some of this experience from his memory.

CHARLES recalled that at the time of his suicide CHRIS was living at his parents residence in Bloomfield Hills (as mentioned above). This was an "affluent" neighborhood, and the Busch house was located on Morning View Drive. At the time of his suicide CHRIS was staying at this house by himself as their parents had traveled to England to visit older brother David, with whom they had a "falling out". CHARLES advised that this "falling out" had to do with David being both a homosexual and "a little bit of an activist".

CHARLES recalled that on the day CHRIS' body was found he had received a phone call from the maid, named Christina, who was at the house and could not gain entrance. Christina was nervous that something was wrong and the dogs inside of the house were barking. Christina went to the neighbors (across the street) who phoned CHARLES. CHARLES could not recall the name of the neighbor that Christina went to, but described them as a Caucasian couple, with a daughter, who were good friends with his parents. CHARLES then phoned the police and left work to go to the house. At the house, CHARLES met up with the police and after entering they found CHRIS' body upstairs in the bedroom CHRIS was staying in. CHARLES recalled that when they opened the door to CHRIS' bedroom he could see CHRIS' body, which was lying on the bed. CHARLES recalled a terrible smell and remembered seeing a shotgun and remnants that CHRIS had been drinking. CHARLES also recalls seeing a painting of a tiger over a chest that had "bullet holes in it". CHARLES does not recall seeing anything else in CHRIS' room, to include any drawings, ropes or ligatures. CHARLES did not recall there being any suicide note as well, and has no recollection of the police ever mentioning this to him. CHARLES advised that he "did not look" at the room or CHRIS' body for very long as he was very traumatized. CHARLES further advised that any items or belongings that were in the room where CHRIS killed himself belonged to CHRIS.

In regards to why CHRIS would kill himself, CHARLES advised that he believes it was due to other molestation charges that were about to be filed against CHRIS. CHARLES seemed to recall a pending case which originated in the Lake Ess area. At the time of his suicide CHRIS was being treated by a local psychiatrist, whose name CHARLES could not recall. When asked if CHRIS could have been bipolar, CHARLES advised that he never noticed any signs of depression or mood swings from CHRIS, and that he always seemed "easygoing". CHARLES qualified this by advising that he was seven years older than CHRIS and had his own life - with a job, wife and five year old son. CHARLES further advised that after the molestation charge(s) surfaced against CHRIS he and his wife kept their distance from CHRIS. CHRIS was "shielded" by his parents and their relationship (between CHARLES and CHRIS) became more "superficial".

CHARLES advised that CHRIS' attorney at the time of his suicide was Keith Stark who is likely still alive.

ASSOCIATES AND VEHICLES FOR CHRIS BUSCH

CHARLES advised that in terms of friends for CHRIS he only recalled that he "hung out" with co-workers of his at his restaurant. CHARLES did not recall CHRIS being involved in any social organizations, with the exception of the Big Brother program. CHARLES recalled that CHRIS did have one friend from boarding school in Switzerland. CHARLES could not recall the name of this friend, but described him as being from Middle Eastern descent, and as residing in the state of Michigan for a period of time.

CHARLES did not recall the name "Greg Greene", nor did he recall CHRIS associating someone by this name.

CHARLES advised that he vaguely recalled a maid who worked at his parent's house named "Christine". CHARLES described "Christine" as a black female, and stated that CHRIS was likely friendly with her "given his personality".

Regarding female associates or "girlfriends" for CHRIS, CHARLES advised that he only recalled CHRIS having one girlfriend from boarding school in Switzerland who he brought back to the United States. CHARLES could not recall this woman's name, and advised that she returned to Europe after she and CHRIS broke up. CHARLES could recall no other women who were associates, or involved with, CHRIS.

Regarding vehicles belonging to CHRIS, CHARLES advised that CHRIS drove a small Chevrolet Vega which was light brown or tan in color. CHARLES also believes CHRIS likely had another vehicle since he recalled the Vega as being an old car. CHRIS also had a Triumph Bonneville motorcycle.

RESIDENCES ASSOCIATED WITH CHRIS BUSCH

CHARLES advised that his parents had two houses they utilized. One was their primary residence in Bloomfield Hills, and the other was a vacation type house they owned near Ess Lake, which was located near Atlanta, Michigan.

CHARLES advised that CHRIS did visit the house on Ess Lake, and was likely to visit it more when he was living in Midland, Michigan (which was closer). CHRIS used to enjoy waterskiing and fishing at Ess Lake. CHARLES advised that CHRIS was more likely to go to the Ess Lake house with his brother John, who lived in Flint, Michigan at the time.

CHARLES advised that he and his wife used to visit the Ess Lake house often. CHARLES stated that he and his wife "outfitted" this house, and would "weekend there" when his parents were overseas.

CHARLES advised that CHRIS had a house in Alma, Michigan which was the same town his restaurant was located. CHARLES advised that he never visited this house, and only could recall visiting CHRIS' restaurant on one occasion.

Regarding a residence in Sanford, Michigan, CHARLES advised that he had no recall of such a place but that it was likely that this was where CHRIS stayed while at Culinary School in Midland, Michigan. CHARLES did recall he and his wife visiting CHRIS one time when he was living in Midland. This was the only time he recalled socializing with CHRIS during this period.

Regarding a residence in Whitehall, Michigan, CHARLES advised that his brother John moved from Flint to Whitehall where he opened and operated a convenience store.

PETS ASSOCIATED WITH CHRIS BUSCH

CHARLES advised that his parents had a Welsh Terrier with white hair, named "Tabatha", that was at their house at the time of CHRIS' suicide.

CHARLES further advised that CHRIS had a his own dog named "Sam" who was a "light tan" color. CHRIS had brought "Sam" back from an island off the coast of Spain. "Sam" was an Ibizan Hound Dog. Earlier in his life CHRIS also had a black schnauzer mix. "Sam" was also at CHARLES' parents house at the time of CHRIS' suicide. It was "Sam" and "Tabatha" that were barking that alarmed Christina the day CHRIS' body was found.

CHARLES advised that after CHRIS' suicide "Sam", in addition to "Tabatha", were cared for by his parents. CHARLES had no idea what happened to these dogs after their death, but advised that his parents were not the type to bury the dogs in their yard.

CHARLES' FEELINGS REGARDING CHRIS BUSCH'S MOLESTATION ACTIVITY

CHARLES advised that other than when the molestation charge surfaced he had no knowledge of any lifestyle CHRIS had with young boys.

CHARLES advised that he was "concerned" when CHRIS was charged with molesting a boy. CHARLES stated that it "seemed like it happened" and he and his wife were scared for their own son. After these charges surfaced, CHARLES and his wife had their son see a psychologist and never allowed their son to be alone with CHRIS.

CHARLES advised that after CHRIS was charged his brother John mentioned to him that he believed CHRIS had molested his own two sons (Brent and Scott Busch). CHARLES advised that John knew this because his sons had informed him of this. CHARLES advised that CHRIS never talked to him about molesting children or about him having fantasies of molesting children.

CHARLES advised that he had no knowledge of CHRIS ever being molested as a child, but that you "just think of boarding school" and think that it could have happened. CHARLES had no knowledge of any molestation which took place within his immediate family, or by anyone associated with he and his siblings in their earlier years (ie; family member, teacher or coach).

CHRIS BUSCH AND THE OAKLAND COUNTY CHILD KILLING CASE

CHARLES advised that he is familiar with the Oakland County Child Killing case, and is aware that at one time CHRIS was viewed as a suspect. CHARLES stated that Timothy King, one of the victims, was from Birmingham, Michigan and disappeared from a supermarket that was

located in CHARLES' neighborhood. When asked if he (CHARLES) had ever thought that CHRIS could have been involved in these killings CHARLES advised that he "would have trouble" believing CHRIS was involved in any "violent crime". CHARLES stated that CHRIS was a "happy go lucky" person who showed no signs to him as being a violent person.

CHARLES advised that neither he nor his wife were ever interviewed by the authorities in regards to the Oakland County Child Killing case.

CHARLES advised that his family never talked about the Oakland County Child Killing case or whether CHRIS could have been involved. CHARLES advised that later in life his father shredded all of the family documents, to include birth certificates, which CHARLES stated was "strange".

CHARLES had no recollection of CHRIS ever being administered a polygraph in regards to the Oakland County Child Killing case. When asked if CHRIS ever talked to him about this case, or his position as a suspect, CHARLES replied "absolutely not". CHARLES was asked if CHRIS was capable of these killings and he replied "that he did not think it was in his nature".

MISCELLANEOUS

CHARLES advised that he graduated from the University of Michigan. CHARLES is currently retired from the General Motors, Chrysler LLC. CHARLES and his wife, Nancy Busch, currently reside in the Chapel Hill, North Carolina area, which is near where their only child, a son, resides with his wife. [Note: This residence is known as _____]

CHARLES advised that his father retired as the Controller of the Cadillac Division of General Motors. Nancy Busch is an artist, and was employed as an advertising executive during the mid 1970s when CHRIS committed suicide.

Photographs for victims Mark Stebbins, Jill Robinson, Kristine Mihelich and Timothy King, provided by authorities in Michigan, were shown to both CHARLES and Nancy Busch, producing negative results.

COLLECTION OF DNA

At the conclusion of the interview CHARLES, in the presence of his wife Nancy, consented to the collection of a DNA sample by the

interviewing Agents. In the presence of Agent Daly, Agent MacDonald collected two buccal swab samples for CHARLES.-

The interview was then concluded at approximately 5:25pm.

1 **4-29-08: *** (Briefed Deputy Chief Don Studt from Birmingham PD on this lead) ***** We met
2 with D.C. Studt today at the Michigan State Police Metro North Post and briefed him on the details of
3 this lead into Chris Busch & Greg Greene. Don was already aware of the beginning of this lead from
4 a meeting he had back in the fall of 2007 with the King family, including Cathy King. We brought
5 Don "up to speed" on the lead and requested that he attempt to locate some reports his agency may
6 have on a child molestation case possibly involving a victim from Birmingham and Christopher
7 Busch back in 1977-78. We told Don that when the FBI was interviewing Chris Busch's brother
8 Charles last week, Charles mentioned a molestation case that his brother Chris was indicted on prior
9 to his (Chris's) suicide, involving a boy whose mother worked as a cashier at Fishers Meat Market in
10 Birmingham, Michigan. We have no record of this incident that Charles told the FBI about. Don
11 stated that there was a Fishers Meat Market in Birmingham for many years, but closed down about
12 ten years ago. Don is going to attempt to locate any Birmingham reports of this incident. Don also
13 mentioned that "Mohegan" street where Charles Busch resided at the time of the King
14 abduction/murder was right around the corner from the Krogers and Hunter Maple Pharmacy where
15 Tim was abducted from.

16 **4-30-08: *** (Task Force Meeting to make our plans for the up-coming search warrant of the**
17 **Busch home at [REDACTED] ***** Present at the meeting
18 today along with myself, was Garry Gray & Dave Robertson (MSP) and John Ouellet & Jason
19 Bollinger from the FBI. We discussed and all agreed that we should have our search warrant "in-
20 hand" when we approach the people living at [REDACTED] MSP Crime Lab to
21 conduct a search of this home for evidence. I am going to type the affidavit (probable cause) for the
22 search warrant from my report on this lead. We will meet with, brief and have an Oakland County
23 prosecutor review our information for the warrant. We will also have Rob Moran from the Wayne
24 County Prosecutors Office present at the meeting. After the sealed/suppressed warrant is approved
25 and signed by a Judge, we will meet with and brief Chief Kurt Bowden from Bloomfield Twp. Police
26 Department on the approach and search of the Busch home in his jurisdiction.

27 We also discussed some of the things we need to do to "tie-up" this lead prior to conducting the
28 search. We agreed we would call Connie Fisher at the FBI DNA Lab and request that she move the
29 Busch DNA to the top of her priority list so we could possible have positive results prior to our search
30 of the Busch home. The following are the remainder of things that need to be done: Locate and
31 interview Michael Boldiszar about Chris Busch, approach Jane Burgesses husband about a possible
32 confession/admission Busch may have made to Larry Wasser in 1977 when Burgess was
33 representing Busch in a criminal (CSC) case, get reports from Birmingham PD and interview the
34 victim in that case, swab & polygraph Vince Gunnels, get copies of police reports from any other
35 agencies along with transcripts of interviews and put together the search warrant.

36 **4-30-08:** After the meeting, Jason Bollinger (FBI) called Connie Fisher at the FBI/DNA Lab in
37 Quantico, Virginia and requested that she move Christopher Busch's DNA to the top of her priority
38 list. Connie stated that she is working on DNA for an upcoming trial that will take her a few more
39 days, but told Bollinger that she would make Chris Busch's DNA a priority with a turnaround time of
40 approximately 4-6 weeks.

41 **4-30-08: *** (Vince Gunnels sister called back today) ***** I finally heard back from Vince
42 Gunnels sister (Karen Zaspel [REDACTED]) that resides in Montana. She stated that Vince has
43 agreed to supply Detectives with a sample of his DNA and also to take a polygraph about having
44 information in our case. She stated that Vince wishes to speak to an attorney prior to doing this,
45 simply to make sure his rights are protected. I told Karen that was fine and asked her how Vince is
46 going to go about getting an attorney, to which she stated that Vince told his counselor at the prison
47 about the situation and about wanting to speak to an attorney about this, but was not getting any
48 cooperation from them. I told Karen that we could call Department of Corrections and see if they
49 could assist us in supplying Vince with an attorney so we could expedite this process, to which she
50 agreed would be great.

1 **5-1-08:** Garry sent an e-mail today to the MDOC Parole board in regards to helping Gunnels get an
2 attorney to talk to prior to taking the polygraph and swabbing him for DNA in the OCK case. Dave
3 Kleinhardt from the parole board sent an e-mail back stating that he confirmed with the Michigan
4 Department of Corrections Administrator of Legal Affairs, that they do not provide attorneys or legal
5 advice to prisoners in such cases.

6 I called Gunnels sister (Karen Zaspel) and explained this to her. She stated that she is absolutely
7 going to attempt to retain legal counsel for her brother prior to him taking our polygraph or collecting
8 her brothers DNA.

9 **5-1-08: *** (Request made to Midland County Sherrifs Dept. for police reports on Busch) *****

10 I called the Midland County Sheriff's Dept. (989-839-4600) today and spoke with "Sally" in records,
11 in an attempt to get copies of police reports on Busch's CSC case in Midland County in 1977. Sally
12 stated that they do not keep police reports past 10 years, explaining that they get shredded after
13 that. She referred me to the Midland County Jail, stating that they may be able to get me a copy of
14 Christopher Busch's booking photo from 3-4-1977 when he was arrested. She also stated that the
15 jail would be able to fax me a copy of their arrest/booking report. I called a "Chris" at the jail and left
16 my name and number requesting copy's of their file # MSO-5651. Sally from records also
17 recommended that I call the prosecutors office at (989) 832-6722 and speak with "Alice" who may
18 have the copies of this case. I called and spoke with Alice at the prosecutor's office and she is
19 attempting to find the file on Chris Busch and will call me back.

20 **5-2-08:** I received a call back today from the manager of the jail in Midland County, Scott
21 Stephenson (989-832-6688). Scott stated that he does have a file including mug shots of Busch and
22 would fax it ASAP. I did receive the faxed file from them, which contained their sex-motivated report
23 on Busch. This report showed that Busch was arrested on 3-4-1977 in Midland County on their 3rd
24 Degree Criminal Sexual Conduct charge, which occurred in Midland County in 1976. This report
25 shows Christopher Busch, was represented by Attorney Jane Burgess in this case. The victim in
26 their case was James Vincent Gunnels. The report also shows that Busch, at the time of the offense
27 was driving a 1975 blue/blue Chevrolet Vega. ***** (See the Midland County file for further details)**
28 *******

29 **5-2-08:** Garry Gray (MSP) called today and stated that he located a receipt that indicates that some
30 of the physical evidence from the Child Killing case, i.e. Hairs, fibers...etc., may have been sent to
31 the FBI Lab in 1997 for future DNA processing.

32 **5-5-08:** I received the packet of reports and court/jail information in the mail from the Midland
33 County Jail today on the arrest of Christopher Busch for Criminal Sexual Conduct in their court
34 3-4-1977. This file also contained an original booking photo of Christopher Busch.

35 **5-5-08:** Garry Gray (MSP) called today and stated that he received a lab report from the FBI Lab in
36 Quantico, Virginia. This report stated that the two partial human hairs found/submitted after the
37 recent examination of the victims clothing by the Michigan State Police Lab, were not suitable for
38 microscopic comparison, but have been forwarded to the DNA Lab at Quantico for Mitochondrial
39 DNA analysis and comparison.

40 **5-6-08: *** (Interview of Larry Burgess. He is the husband of Jane Burgess (deceased) who**
41 **represented Chris Busch back in 1977.) ***** Garry Gray & I went to [REDACTED]
42 today (Buhl Building) to the offices of Burgess & Burgess and interviewed Larry Burgess. After
43 introducing ourselves, Larry indicated that he knew why we were there because James Feinberg
44 who represents Larry Wasser, is a partner in their law firm. I explained to Larry anyways, why we
45 were there, the seriousness of the case, the age of the case and the importance of this case to the
46 families of the victims, whom we, the Task Force, remain in close contact with. Mr. Burgess stated
47 that he had discussed this with Mr. Feinberg, could not find any files on this and all he can
48 remember is that the subject's name was Chris. I explained to Mr. Burgess how Larry Wasser's
statements led us to his office, but that it was not his statements alone that brought us there today,

1 as much as the circumstantial case that we have developed on Christopher Busch about the child
2 killings, since Wasser's statements, that corroborate what Wasser said to the Polygrapher Patrick
3 Coffey. Mr. Burgess indicated that he does not have the "Smoking Gun" type statement that we're
4 hoping for, but stated that if he did he would definitely try to supply us with that information, but
5 would have to consider is ethical responsibilities in doing so. Larry then mentioned that even though
6 his wife Jane Burgess and her client Chris Busch are deceased, there remains an attorney client
7 privilege. I explained to Larry that Chris Busch was charged in 4 counties in Michigan at one time in
8 1977 for child molestation. Larry agreed to talk with us and help us if he could. I asked Larry how
9 his wife or law firm came into contact with Christopher Busch, to which he stated that another
10 attorney friend of his referred Busch to their firm. Mr. Burgess indicated that he normally would have
11 handled the Busch case, but stated that he was tied up on another case at the time so his wife Jane
12 represented Chris Busch. Larry stated that his wife did an excellent job representing Chris, stating
13 that she kept him out of prison, even though Chris was facing some very serious charges. Mr.
14 Burgess told us that the Busch family was very wealthy, indicating that Mr. Busch was in a very high
15 position in the General Motors Corporation. He stated that Mr. & Mrs. Busch paid his firm a lot of
16 money to represent their son, including flights for Jane Burgess to all the different counties in
17 Michigan where Chris was charged in. Larry stated that the reason Mr. & Mrs. Busch spent so much
18 money representing their son was not because they cared about him, stating that they were "very
19 cold" people, but that they were embarrassed by Chris and were only concerned about their
20 reputation in the community. Larry stated that his wife (Jane) went to the memorial service in 1978
21 after Chris committed suicide and that Chris's parents would not even approach or acknowledge
22 Jane's presence because they were afraid others would make the connection to her.

23 Mr. Burgess mentioned the case against Chris in Montmorency County. I mentioned that it
24 appears that the Busch parents followed Chris around the state posting bonds for him and cleaning
25 up his messes. Again Larry stated that they were concerned about their reputation and did not like
26 Chris, stating that they old did those things to keep it quiet. I told Larry that Mrs. Busch even
27 approached one of the boy victims one time and tried to "Pay the boy off" to not testify against her
28 son. Larry asked if that was the boy from Montmorency, which I stated it was (Vince Gunnels). Mr.
29 Burgess then started to talk about the cottage the family owned in Montmorency County on a lake,
30 stating that Chris had offered the cottage to their family to use. Larry stated that he, Jane and their
31 boys went up and stayed at the Busch cottage (Ess Lake). Mr. Burgess told us that while they were
32 at the cottage, Chris stopped over to visit and was staying somewhere in the area. Larry told us that
33 he had some concerns about Chris being there due to knowing what Chris had been charged with,
34 but added he (Larry) didn't feel Chris was the type that could hurt someone. Mr. Burgess stated that
35 he thinks that Chris stayed and cooked a meal for his family because Chris loved to cook and was a
36 chef. Larry stated that Chris did not say much to him stating that Chris was uncomfortable around
37 him and most adults, but remembers that Chris would talk to his wife Jane and really liked her. I
38 asked Larry if he remembers where Chris was staying at the time and if it could have been in
39 Alpena, to which he stated, "No, he doesn't remember. " I asked Larry if he remembers what Chris
40 drove to the cottage in that day, to which he stated, "No."

41 Larry began talking again about how much his wife grew to like Chris, stating that because Chris
42 was a chef and enjoyed cooking, he made a gingerbread house for their family that his wife would
43 put out at Christmas time. Larry stated that his wife was really upset when the kids accidentally
44 broke it one day after Chris had died. Larry also stated that Chris worked as a chef for the elderly
45 somewhere in the area where he lives. Mr. Burgess talked about Chris being a nice guy, kind of
46 quiet and appeared to be a mild tempered guy, But. Added that he didn't know Chris very well.
47 Garry asked Mr. Burgess if he knew about Chris being looked at by the Child Killer Task Force at the
48 time of the killings, to which Larry stated, "No." I asked Larry if he remembers his wife (Jane)
49 mentioning to him that Chris had been polygraphed about the child killings by the State Police in
Flint a few months prior to Burgess & Burgess getting Chris's case, to which Larry stated, "No."

1 Larry stated that he and his wife Jane definitely had conversations about clients and discussed their
2 cases, but stated that he just doesn't remember much about their conversations involving Chris.

3 We asked Mr. Burgess if his law firm was using Larry Wasser's polygraph services a lot back then,
4 to which he stated that yes they were using Wasser then, stating further that their Law Firm would
5 never allow a client to take a police polygraph prior to taking a private polygraph. I asked Larry if he
6 remembered his wife telling him that Wasser had called to tell her that her client and failed the
7 polygraph in their case and made mention during the pre-polygraph interview that about possible
8 involvement in the Oakland County Child Killings, to which Burgess stated, "No." I told Mr. Burgess
9 that during a phone conversation with Larry Wasser a few months ago, I asked Wasser how he
10 knew that Chris Busch had committed suicide approximately a year and a half after he had
11 polygraphed him? Wasser stated that he had a conversation with Jane Burgess, shortly after
12 Busch's death, at which time Wasser inquired about Busch, to which Jane Burgess told Wasser that
13 he (Wasser) didn't have to worry about it anymore because the guy killed himself. I asked Mr.
14 Burgess if he remembers this or his wife discussing this with him, to which he stated, "No." After
15 some conversation off the subject, I asked Larry if he thought that, based on what he knows about
16 Chris Busch, his family situation and the circumstances of his cases, could he see Chris Busch,
17 having possibly been involved in the Child Killings? Before I could complete the question, Larry
18 spoke up and stated, "Yes, he could." We terminated the interview at this point and asked Mr.
19 Burgess to call if he remembers any other information about Chris Busch, to which he stated he
20 would.

21 Approximately an hour after we left the Burgess & Burgess law firm, Larry Burgess called me and
22 stated that one of his son's remembered what Chris Busch was driving the day he came over to the
23 cottage on Ess Lake to visit the Burgess's, stating that Busch was on a motorcycle.

24 *** The information about Chris Busch staying somewhere else in the area of the cottage and
25 driving a motorcycle over to the Busch, cottage, corroborates what Vince Gunnels & Kenneth
26 Bowman had told us during earlier interviews. Gunnels told us that Chris Busch took him to a house
27 near town, not too far from the cottage on Ess Lake, where Busch showed Gunnels child pornography
28 films of boys being tied up and anally molested. Gunnels told us that Busch gave him Marijuana and
29 beer, undressed him and tried to tie him up and anally molest him. Gunnels stated that he ran from
30 the bedroom at this house and Busch told another subject in the house that Gunnels did not see, "I'll
31 take care of this," as Busch ran after Gunnels. Gunnels told us that after Busch caught up with him,
32 Busch did not force himself on Gunnels. Gunnels also stated that he remembers that Busch had a
33 lot of "toys" at this house, referring to snowmobiles, motorcycles...etc. When we interviewed
34 Bowman about the cottage on Ess Lake, Bowman kept saying that he was never at a cottage
35 stating that he thought it was a house that Busch lived in with another guy.

36 **5-7-08:** Garry Gray (MSP) and Jason Bollinger (FBI) went to the Detroit office of the FBI today to
37 research their files regarding the MSP report Sgt. Gray found indicating that some of the physical
38 evidence (hairs, fiber..etc.) from the child killing case had been forwarded to the FBI for future DNA
39 analysis and comparison.

40 **5-7-08:** While I was writing the Affidavit for the search warrant today for the upcoming search of
41 Busch's home in Birmingham, I was reviewing my report from the fall of 2007, when I noticed
42 something that contradicts what Wasser has been maintaining about not taking a confession from
43 Busch during the pre-polygraph in 1977. According to my notes on 10-01-07, in the Livonia report
44 on this lead, I wrote that Wasser's attorney, while arguing his motions on the record in front of Judge
45 Kenny, stated that in 1977, when Jane Burgess brought her client to Wasser for a private polygraph,
46 it was in regards to a separate CSC charge unrelated to the child killing case. Attorney Feinberg
47 went on to say that it was during the pre-polygraph interview on this separate CSC that this subject
48 confessed to the child killings. My notes also indicate that Feinberg's statements about his client
were made on the record.

1 I called A.P.A. Rob Moran today at the Wayne County Prosecutors Office and requested that he
2 secure the Task Force a copy of the transcripts from these motions heard in Judge Kenny's
3 courtroom on 10-1-07. Rob stated that he would talk to the court report in that courtroom and
4 request a copy of those transcripts.

5 **5-8-08:** I received a letter in the mail today from James Vincent Gunnels at the Ryan Correctional
6 Facility (MDOC). A copy of this letter was also sent to Col. Munoz (Michigan State Police), David
7 Gorcyca, (Oakland County Prosecutors Office), along with the Parole Board at the Michigan
8 Department of Corrections. In this letter Gunnels indicates that he is willing to submit to DNA testing
9 and a take a polygraph test, but only if he can take both through an independent source.

10 I called Gunnels sister in Montana (Karen Zaspel) and left a message with her that we already
11 have Gunnels DNA through the prison system, so the only issue is the polygraph and taking an
12 independent polygraph is not an option. I stated that we have cleared hundreds of people in this
13 case using our polygraph examiners and Vince either takes the test through us or he is considered
14 to be refusing to take it, and in that case I guess he is on his own. *** (See letter in Gunnels file
15 for further details) ***

16 **5-12-08:** Garry Gray (MSP) received an e-mail from the Michigan Department of Corrections
17 Parole Board today, indicating that James Vincent Gunnels parole has been denied. The e-mail
18 stated that Gunnels would be up for review again in February of 2009. *** With Gunnels parole
19 getting denied and the message I left his sister about our polygraph being the only one he can
20 and a private polygraph not being an option, we may get now get a response out of Gunnels
21 indicating that he wants to cooperate with us and take our polygraph on the OCKK case.

22 **5-16-08:** I was reading through the Livonia Police Investigative report today on the Homicide of
23 Timothy King and observed something "interesting" in Detective Sergeant Varajon's notes. During
24 the autopsy of King, the Medical Examiner recovered a hair on the scrotum of the King boy. This
25 hair was collected at the autopsy by Detectives and is listed on the Michigan State Police Lab report
26 that contains all the physical evidence collected from King during his (King) autopsy.

27 Three days after the autopsy, Livonia Detectives met with personnel from the MSP Crime Lab,
28 including civilian Evidence Technician James Hauncher. Detectives were told that the hair found
29 and recovered from Tim King's scrotum during the autopsy, is suggestive of a human facial hair, but
30 more testing would need to be done. *** This is interesting, due to the fact that it appears that Chris
31 Busch still had his full beard at the time of Tim King's disappearance. The location of this facial hair
32 on King's body could also be explained, due to the fact that Busch was known to perform oral sex on
33 his young male victims.

34 **5-26-08: Investigation continues.**

35 **6-10-08:** I spoke with D/Sgt. Garry Gray (MSP) today about this lead. Garry stated that he
36 received a phone call last week from Connie Fisher at the FBI/DNA lab in Quantico. She stated that
37 Christopher Busch's DNA, along with several of the other suspects that we submitted have been
38 compared to the hair from Timothy King's mouth with negative results for a "match." She also told
39 Sgt. Gray that she is currently processing the partial human hairs that have been recently submitted
40 for Mitochondrial DNA (recovered during the recent re-examination of the victims clothing) and once
41 a profile is developed from these partial hair fragments, she will compare Busch and associates
42 DNA to the DNA profile of these fragments. *** Not the news we were hoping for, but not completely
43 bad news. Our suspects DNA will still be compared to the two hair fragments from our victims
44 clothing. We also have the white animal hairs from 3 of the 4 victims clothing. We will be searching
45 for white animal hairs during the execution of the upcoming search warrant at the Busch home. We
46 will have a private laboratory in California compare the animal hairs we recover from the Busch
47 home to the white animal hairs found on our victims clothing.

1 **6-16-08:** So far, the State Police have been unable to locate the possible human facial hair that
2 was recovered from Tim King's scrotum during his autopsy in 1977. This hair was tagged by Livonia
3 Detective Varajon and turned over to the State Police Crime Lab personnel for processing the day of
4 King's autopsy. Warner Spitz told Detectives at the time this hair was recovered from King, that it is
5 more than likely a suspect's hair.

6 I called the Livonia Property Officer (Scott Tar), and asked him to see if he can locate this hair from
7 King that may have possibly been returned to Livonia by the State Police.

8 **6-17-08:** I went to the home of Ronald "Skinny" Eads today on Reeck Rd in Woodhaven in an
9 attempt to show him photos of Christopher Busch, Greg Greene, Kenneth Bowman, Vince Gunnels
10 and others. Ted Lamborgine took "Skinny" with him to meet other pedophiles in the metro Detroit
11 area in the mid to late 1970's, so if there is a connection between Busch/Greene & Lamborgine,
12 "Skinny" may be able to make this connection, especially since it looks as if Busch may have been
13 involved in a child porn ring with other pedophiles in the area. There was no one home at the Eads
14 so I left a card in the door for "Skinny" to call me. **The only connection so far between Chris
15 Busch & Greg Greene is from Kenneth Bowman, who said he thinks he saw Busch & Greene
16 with Lamborgine, dropping a boy off at a house in the 70's.**

17 **6-18-08:** Officer Tar called me back today and stated that he was unable to locate any evidence
18 from the 1977 Timothy King Homicide case that may have been returned to us by the state police.
19 The only evidence connected to the King Homicide, Case # 77-0006883, located in the Livonia
20 Police property room was evidence collected by me over the past 4 years, during our recent
21 investigation.

22 **6-23-08:** Tammy Eads called me today and gave me "Skinny's" new address, stating that he no
23 longer lives with them in Woodhaven. She told me that "Skinny" is now living at [REDACTED]
24 [REDACTED] and that he is willing to meet with me. "Skinny" is supposedly living with
25 Tammy's niece' "Tina," who has a cell phone number of [REDACTED]

26 **6-25-08:** I "ran" Boldiszar, Michael through the "Lexis-Nexis" computer database again today in an
27 attempt to locate him for an interview. He still shows the Berkley address, which is not a valid
28 address for him. I also ran him through the Secretary of State & L.E.I.N. systems to see if he had
29 any new warrants issued or had been arrested recently, both of which were negative. S.O.S did not
30 show a new address for him.

31 **6-25-08: *** Interview of Ronald "Skinny" Eads today. ***** I went to [REDACTED]
32 [REDACTED] today and interviewed "Skinny." This interview was an attempt to see if there is any
33 connection between the "Busch & Greene lead" and the "Lamborgine & Moore lead." I showed
34 "Skinny" photos of Christopher Busch and Greg Greene, both of which "Skinny," right away, stated
35 he did not recognize either one. "Skinny" said as soon as he looked at their photos, "I never seen
36 them before." I showed him a photo of James "Vince" Gunnels and as soon as "Skinny" looked at
37 his picture he stated, "Yah I know him, I seen him at Bob Moore's house on Henry." I asked
38 "Skinny" if he was sure he had seen the guy (Gunnels) in that photo before, to which he stated, yes
39 he remembers seeing him several times at Bob Moore's house. I told "Skinny" that Gunnels looks
40 like a lot of teenage boys that might have hung around with Bob Moore, to which "Skinny" insisted
41 that he knows Gunnels from Moore's house, again stating that had seen him there several times,
42 drinking in the mid-late 70's when he and Gunnels were both 16-17 years old. I asked "Skinny" if
43 there was anyone else he could think of that was at Bob Moore's on those occasions when he states
44 this Gunnels was there, that could verify his story. "Skinny" said that Herbie Lankey, Greg Yates,
45 Donald Fritsch or Johnnie Benson might remember Gunnels or seeing him at Moore's house.

46 Tammy Eads, "Skinny's" sister-in-law called me after the interview, and stated that Johnnie Benson
lives in North Carolina and that his real name is Albert, last name something like OTIMUS but she
wasn't sure how to spell it. Tammy said that Benson went by Johnnie Benson, but his real name is
Albert Benson or Albert Otimus. The last photo I showed "Skinny" was Kenneth Bowman's photo.

1 "Skinny" stated he thought he remembers seeing him at Moore's a couple of times, but wasn't sure.
2 "Skinny" did say that he thought the name sounded familiar too.

3 Tammy Eads was present at the interview and took photos of the pictures I showed to "Skinny" so
4 she can run them by her husband Robert Eads and others that may know these guys. She is going
5 to call me after she shows the pictures around. *** No "solid" connection was made during the
6 interview with "Skinny" today, between the Lamborgine Lead and the Busch & Greene lead,
7 but "Skinny's" reaction to the photos of Vince Gunnels was interesting. "Skinny" insisted he
8 had seen Gunnels at Bob Moore's house several times. *** I didn't get the impression that
9 "Skinny" was trying to make Gunnels fit. "Skinny" right away stated he did not recognize
10 Busch or Greene when shown the photos. We have determined that Busch was into child
11 pornography, films, magazines, boys being tied up and anally molested. Busch would have
12 to have a source to obtain this child porn, especially in those days. Just a possibility, but
13 Bob Moore was someone who would supply area pedophiles with child porn movies & with
14 boys.

15 **7-2-08: Task Force meeting today at the MSP Metro North Post.** Present at the meeting today,
16 along with myself was Garry Gray (MSP) and John Ouelett & Sean Callahan (FBI). Callahan took
17 Jason Bollinger's spot on the Task Force after Bollinger was transferred to FBI Surveillance. We
18 discussed the Busch/Greene lead today and what we want to do next. Prior to executing the search
19 warrant at the Busch Home on Morningview Terrace, we are going to bring Wasser in on the
20 investigative subpoena he is still under and question him further under oath. Ouelett & Callahan
21 are going to go speak with Gunnels at the Ryan Facility to see if they can get him to cooperate
22 further and take the polygraph. I am continuing to type the affidavit for the search warrant. We are
23 also going to set-up an informational meeting with the prosecutors from Oakland County who will be
24 reviewing the search warrant, to brief them on this lead and bring them up to speed on our
25 investigation and plans.

26 **7-7-08: Possible Hastings/Dagner connection.** Garry Gray called me today, and stated that in
27 response to his e-mail to Helen Dagner about the DNA of Hastings, he received an e-mail from her
28 stating the following: She stated that she found in her notes from an interview of John Hastings in
29 1991, that when she told him that her husband Wally Dagner (Rogers City Policeman) committed
30 suicide on November 20th, 1983, Hastings stated to her, "That's interesting, because a friend of mine
31 killed himself November 20th, 5 years earlier." This is the day that Christopher Busch killed himself.

32 **This may explain the house near Alpena that Gunnels/Bowman & Larry Burgess were all**
33 **referring to that Busch was staying at. It may also be that Wally Dagner committed suicide**
34 **because of his involvement with Busch & the killings and Helen has been covering for him all**
35 **these years. Maybe Wally Dagner owned the house outside of town where Gunnels, was**
36 **molested by Busch. Gunnels stated that there was another person in the house and that he**
37 **didn't know if it was Busch's house or if Busch just stayed there. Garry Gray told me today,**
38 **that he confirmed that Wally Dagner did in-fact commit suicide November 20th, 1983.**

39 **7-22-08:** Garry Gray told me today that Helen Dagner had the name Chris Busch "Flagged" in her
40 notes from the Hastings interview and also stated that maybe Hastings was telling her someone
41 else's story when he was discussing the OCCK cases with her during those interviews in the early
42 90's. Over the years Helen Dagner has been very adamant about Hastings being the Oakland
43 County Child Killer, based on supposed circumstantial information that she developed through
44 interviews with Hastings. She has maintained that Hastings has details about the killings that only
45 the killer could know. The task force investigated Hastings in the 90's and cleared him. This
46 included Hastings passing 2 polygraphs in the OCCK case.

47 ****** The current Task Force is going to investigate this possible connection/friendship**
48 **between Busch & Hastings independent of Helen Dagner. ******

1 7-22-08: I went to The Oakland County Medical Examiners Office today to try to get a copy of the
2 Autopsy Protocol on Christopher Busch. The death certificate showed that an autopsy was in-fact
3 conducted by Oakland County M.E. Robert Sillary. This is the same Medical examiner that did Jill
4 Robinson & Kristine Mihalich's autopsies. The only record that they had in the Busch file was a very
5 basic Autopsy type cover sheet that said general information, along with a toxicology cover sheet.
6 The autopsy sheet had Busch's name, M.E. case # 78-2221, 27 year-old white male, the date of the
7 autopsy, Nov 20th, 1978 at 1:00pm, Cause of death (Gunshot wound to the head), manner of
8 (Suicide) and was signed by Robert Sillary. The Toxicology report stated that Christopher B. [REDACTED]
9 blood alcohol level was a 0.41%, signed by Robert Sillary. I spoke with several employees at [REDACTED]
10 M.E.'s office and asked about the rest of the report or a more detailed report of the autopsy. [REDACTED] was
11 told that M.E. Robert Sillary had been fired from the M.E.'s office and his report's or lack there-of
12 was one of the problems Sillary had there. I was told that the cover sheets are all they have on the
13 autopsy of Chris Busch. *** (See copies in Busch file) ***

14 7-23-08: I identified a Dr. Bruce Garretson today, who was the next-door neighbor boy of the Busch
15 family in the 1970's. Bruce Garretson was approximately the same age as Chris Busch, but a few
16 years younger. Bruce Garretson's mother still lives in the same house at [REDACTED]
17 [REDACTED] Bruce had an older brother named Marc Garretson that died in 1992. These
18 boys may have known Chris Busch and/or John Hastings from the neighborhood and Bruce may be
19 able to connect Busch & Hastings through an interview and/or photographs of Busch, Hastings,
20 Greene..etc. Bruce is an Opthamologist that lives in Bloomfield hills and practices in Rochester
21 Michigan. According to the Secretary of State, Garretson currently resides at [REDACTED]
22 [REDACTED]. His D.O.B. is [REDACTED]. A check on Bruce Garretson through the
23 Lexis-Nexis database shows the [REDACTED] address current through July of 2008. This check
24 also shows another address for Garretson at [REDACTED]. It shows
25 this to be a good address for Garretson through July of 2008 and shows that this address is a
26 hospital in Cook County Illinois. There is also a current address as of January of 2008 in this report
27 that could be his medical practice in Rochester, Michigan. This address is [REDACTED]
28 [REDACTED] *** Hopefully an interview with this subject will help us
29 identify and confirm associates of Christopher Busch and the Busch family. ***

30 7-25-08: Garry Gray (MSP) had information that Chris Busch and John Hastings may have both
31 worked at one time, together at either "Biff's" restaurant in Bloomfield or the "Maple-House" in
32 Bloomfield. Both guys were either cooks or chefs. I performed a "Google" search and a "Lexis-
33 Nexis" search on both restaurants, neither of which resulted with a positive response.

34 8-13-08: I called and spoke with Dr. Bruce Garretson today about meeting with him to discuss
35 some old neighbors on Morningview Terrace from back in the 70's. Dr. Garretson right away said
36 you must be talking about the Busch's whose son killed himself back then. I told him that I was
37 looking for his help in an old case and wanted to meet with him to look at some pictures. Dr.
38 Garretson stated he would help in any way he can, stating that he moved out of the home on
39 Morningview Terrace at age 18, in 1974 and doesn't really remember much about the Busch family.
40 Garretson stated that his mother who still lives on Morningview Terrace might know more about
41 them than he does. Dr. Garretson asked if the son who killed himself was a "big guy," to which I
42 stated he was a heavy-set guy. Dr. Garretson said that he kind of remembers him but wasn't sure.
43 Dr. Garretson stated that he is off work and will be at his home [REDACTED] next week if
44 investigators wanted to come by. The Dr. supplied a home phone number of [REDACTED]
45 [REDACTED]

46 8-18-08: *** (identified where Michael Boldiszar is possibly staying) *** I have periodically
47 been checking Boldiszar's name in the Lexis-Nexis database and through the Secretary of State to
48 try to locate him for an interview about Chris Busch. I checked his name in the Secretary of State
Computer today and it showed a Michael Joseph Boldiszar, born [REDACTED] to reside at [REDACTED]
[REDACTED] I performed a check through "Mapquest," which

1 showed this address to be located on the west side of Manistique Lake in the Upper Peninsula
2 near Curtis, Michigan.

3 **8-20-08:** Garry Gray sent me a copy of an e-mail today that he forwarded to FBI Agent, "Tommy"
4 McDonald, the agent that interviewed Charles Busch for us. Garry is requesting that Agent
5 McDonald re-approach Charles Busch with a few more questions we want to ask him.

6 **8-20-08:** I called and spoke with Dr. Garretson today about possibly interviewing him tomorrow at
7 his house. Dr. Garretson agreed to speak to us tomorrow morning at 9:00am at his house in
8 Bloomfield Hills. Garry & I will be going to interview Dr. Garretson and show him some pictures of
9 Busch, Greene, Gunnels, Bowman, Hastings...etc. (Garretson's house is at [REDACTED])
10 [REDACTED]

11 **8-21-08: *** (Interview of Dr. Bruce Garretson about Busch) ***** Garry Gray (MSP) & I
12 interviewed Dr. Garretson at his home today on Mitchell Court in Bloomfield Hills. Dr. Garretson
13 grew up across the street from the Busch Family, but was 4-5 years younger than Christopher
14 Busch. Dr. Garretson didn't remember much about Christopher Busch's physical appearance
15 except that Busch was a heavy-set guy. I asked if he remembers what Chris Busch was driving
16 back in the 70's, to which he stated he thinks it was a small, blue, older car. Dr. Garretson then told
17 Detectives that his mother might be able to help us more, being that she was a "stay-at-home" mom
18 and had dealings with the people in the neighborhood. Dr. Garretson stated that his sister recently
19 told a story about coming home one day, when she was a little girl, with a Polaroid photo of a man's
20 genitals and showing their mother. Dr. Garretson did not know where the photograph came from,
21 but stated that his mom might be able to tell us if she got it from Christopher Busch. Dr. Garretson
22 also told Detectives about a couple of other mom's in the neighborhood that stayed home during the
23 day that may have had a closer connection with the Busch family than his family did. He mentioned
24 the "Savoie" family that own Mike Savoie Chevrolet. Dr. Garretson also mentioned the "Hoffman"
25 family that lived directly across the street from the Busch's. Garretson stated that he thinks Mrs.
26 Hoffman was fairly close to Chris Busch's mother and that Hoffman's had boys the same age as the
27 Busch boys and might be worth us talking to. Dr. Garretson also stated that he believes Mrs.
28 Hoffman still resides on Morningview Terrace across from the old Busch home. **Even if Dr.**
29 **Garretson's mother isn't willing to talk to us, maybe the sister would, about whether or not**
30 **Chris Busch gave her that photograph back in the 70's.**

31 **8-22-08; ***** I was reviewing the Christopher Busch suicide report that Bloomfield Twp. PD wrote on
32 November 20th, 1978, when I noticed that a neighbor couple, at the time of the suicide, told police,
33 that they were close with the Busch family and Chris Busch. This was William & Christine Aitkens
34 that resided at [REDACTED], right down the street from the Busch family. I
35 performed a check through the Lexis-Nexis computer database and located both William & Christine
36 Aitkens. The results of this check, showed **both of these people to now be DECEASED.**

37 **8-22-08:** I went to [REDACTED] today in Bloomfield Twp with Livonia Detective Greg
38 Abraham, and took a few photos of the former "Busch" residence.

39 **8-25-08: *** Identified Dale Arthur Cooper today possibly living in Texas.. Multiple state**
40 **criminal history from Michigan in 77, to Las Vegas 11-23-78...many arrests and several states**
41 **including living all over the country...******* I began searching today, trying to identify Dale
42 Cooper. This subject is listed as also being arrested, in the State Police report from 1977, when
43 Busch & Greene were arrested for multiple counts of Criminal Sexual Conduct in Flint. After Busch
44 and Greene were cleared (by polygraph) of involvement in the OCCK case, the newspaper reported
45 that the 3 Flint men have been cleared. The State Police report has Cooper listed as arrested, but
46 does not explain his involvement/connection to Busch & Greene or anything about his charges. This
47 subject appears to be alive, living in Texas and **needs to be interviewed about his connection to**
48 **Busch & Greene. *** (See Cooper file for Criminal history records and current addresses) *****
49
