PROGRESS REPORT: 8-9-73

Dorothy Burnett, 11910 Adel, 444-8440, called the homicide office this date and said that after hearing about this case on television she remembered something that happened about 2 years ago that might be related to this case.

She stated that one evening as she was driving past the intersection of Gears Rd. and IH 45 that she noticed 2 men carrying a large plastic bag toward a hole that had been dug in the field at the Northwest corner of this intersection. She stated that one was an older, larger WM and the other was a younger, smaller WM. They were in an old modle green pick-up that was parked on the side of the road.

She stated that if necessary she can take us to the approximate location of where the hole was dug.

Horace J. Lawrence Jr., 310 W. 31st, 862-9947. Mr. Lawrence stated that on June 11th, 1973, his son, BILLY RAY LAWRENCE WM15, had left home. The night he left Billy called his father and told him that he was going to lake Sam Rayburn to go fishing. On June 11th, Mr. Lawrence received a letter from his son that was postmarked June 6th. In this letter Billy told him that he thought that they should stay apart for awhile as rhthey had been having trouble and that he was in Austin and would work there for the summer. He also stated that he would come back to Houston between 8-1-73 and 8-15-73. Mr. Lawrence has not heard from Billy since this letter.

Mr. Lawrence did not make a missing persons report because he felt that his son would return. However, ~~EXXX KENNETH ALLEN BEARDSLY~~, WM18, 420 W.31st, 862-5251, told Mr. Lawrence today that Billy knew Wayne Hensley. This is why Mr. Lawrence reported this.

He described Billy as follows; WM15, 5'11½", 140-155 lbs., no broken bones or surgical scars, had long lt. brown hair. He also stated that Billy's rental records are with Dr. William George, Ashland at 20th. Mr. Lawrence will advise us if he hears from his son.

Officers went through the missing reports on file in juvenile and missing persons and Officers found the report of James Stanton Dreymla missing since 8-3-73. The description of this missing youth fit the general description of one of the bodies found in the mass grave on Silverbell. Officers checked into the reports that came from the location on Silverbell and found that a bicycle fitting the description on one that James Dreymla rode off from his home. This bicycle was a homemade one with a large front wheel and small rear wheel. It had been registered with the bicycle detail under reg #105457 and ser #064342 officer Kennedy checked and found that this bicycle found in the backstall on Silverbell was in fact reg # to James Stanton Dreymla. Officers then received a call from Mr. Dreymla and he told officers that he had just had a call from his wife who had stated that a Houston Chronicle reporter had been to the house and wanted a current picture of her son as he was found in the mass grave. He said that he had been notified at all about and wanted to know if this was true and why he had not been notified before the newspaper. Officers checked into this and found that no positive I.D. had been made at all and that reporter had no authority to come to their house. Officers then asked him to come to the station to review what had been found at this time. Mr. Dreymla came to the juvenile division and officers took him to 700 Houston Avenue to see if he could ID the bicycle that had been found in the boat storage. Mr. Dreymla accompanied officers and told officers that this was his son's bicycle. He then came back to the juvenile division and told officers that he did not want to go to the morgue to view a body as this would be more than he can take. He asked if he could have a neighbor who know the boy well I.D. the body, and officer Massey called the Medical Examiner who stated that the bodies were not in any condition to view at this time and the stated that they would first try and I.D. the body by dental records. Officers were then asked if they would take Mr. Dreymla to homicide Division. Officers took him to Det. Seibenacher who is assigned to this case and he told Mr. Dreymla about the evidence that has been turned up at this date and all indications pointed to the fact that the young boy found in the grave is in fact James Dreymla. Mr. Dreymla then stated that he would be at home if anyone wanted to contact his work is 427-5611 EXT. 374. Officers traded information with DET. Seibenacher and were asked to make supplement on all current information.

He told me that he lived in Houston during 1970-1971. And that he was
 living at 90 1/2 Tulane. He said that he had two sons.

He said that during this time that his two sons got to messing around
 with homosexuals and that he just couldn't stop them. He said that
 on or about January 30, 1971 his two sons were supposedly going to
 the Merchants Park Bowling Alley to join a league. This is the last
 that he has seen or heard from them. He was wondering if perhaps
 any of the bodies recovered here in Houston could be his sons. He said
 that the boys had had dental work done when they were attending

RUTHERFORD ELEMENTARY SCHOOL in Jacksonville, Florida. The school had
 sent them to the school health center and that the school might possibly
 be able to help locate the dental records.

He said that some of the names mentioned that his sons were chumming
 with were a BILL WALLS and a ROY AMES.

He said that if he could help in any other way to call him collect at
 any hour of the day or night.

I went to Juvenile and they did have a missing report on these two boys.
 The records are stored but the Juvenile Division will get the records
 and send us a copy. The Juvenile numbers for the boys are :

In talking to Detective Larry Earls I learned that he had found two
 bodies in one grave at 4500 Silver Bell. Along with the bodies he found

PROGRESS REPORT

We, Young, Baker, Porter, Paulk and two Pasadena Police officers who had one of the defs in custody left The main police station in Houston on 8-9-73 at approximately 3:30pm in three cars and drove to San Augustine County by way of Lufkin, Texas where we met the Texas Rangers DUB CLARK and Charlie Neal. The def in custody was WAYNE HENDLEY and he had told the Pasadena Officers that he wanted to show us where the the bodies of some of the people that he had killed and that BROOKS had killed along with a subject named CORILL and CORILL is the one killed by WAYNE in Pasadena that led to the investigation into the multiple murders being investigated at this time. Officers were then met by the Sheriff of San Augustine County and this was MR. HOYT and he had several of his deputys with digging tools and all of these officers were led by WAYNE to a secluded spot in the Nat'l forest where Wayne went into the thick woods and in a short time there were two graves located and the bodies removed by ambulance and these two bodies were sent to the ME'S by order of Sheriff Hoyt. A series of photos were taken by the photo man that the Sheriff called and these will be available to us later. A REPORT WILL BE MADE BY SHERIFF HOYT REGARDING THIS FIND and ALSO Officer went back to this same location and again with the def Wayne were led to more graves and two more bodies found and these also sent to Lufkin, Texas. On the night of the 10th and this would have been about 2:00am; Sheriff Hoyt along with...the City Attorney there and a magistrate gave the legal warning and then filed two counts of murder against WAYNE HENDLEY and in the early am about 5:30am all of the officers that had left Houston returned to the Sheriffs office and it was then that the second trip was made and while at the scene it was learned that the charges had been filed and the Sheriff at this time is continuing the investigation there. About 9:40am...this date...officers from Pasadena and Houston and again with the def left San Augustine and started for another location where Wayne said there were five more bodies they had killed and buried and this was of the beach at High Island. NOTE: while the Sheriff Hoyt had Wayne in custody, Wayne complained that he felt nervous. Hoyt called Dr. Healy and he came and checked the def... this should be also contained in the report from there.

Upon arriving at High Island still with Texas Ranger Neal and the Pasadena Officers and Houston officers already mentioned, officers were met by More Houston Detectives, these were J.R. JAMES, NED NEWMAN, JACK HAMEL AND JAMES TUCKER AND THEY HAD THE DEF, DAVID OWEN BROOKS. Also trustys were along to help dig. Brooks stated as did Hendley that it had been a year since they had been there and BROOKS stated that Corll had taken him there over a year ago and pointed out a spot to him and said he had captured and killed a boy and had buried him and the place was by a large rock. Upon arriving at the beach BROOKS walked around a few minutes and pointed out a large rock and said this looked like the spot he had seen. This location was dug up and a body found there. Then both BROOKS AND WAYNE HENDLEY walked around and pointed out a second spot and this was dug up and a second body was found. The Sheriff of GALVESTON COUNTY was in ~~XXXXXXXXXXXXXXXXXXXX~~ with us and the Sheriff of CHAMBERS county was there and the bodies were in his jurisdiction and he directed an ID man from Galveston County to take a series of photos and these will be sent to us. The defendants then directed officers down the beach and said more bodies were buried along this area and this was in another county yet, this was Jefferson County and the officials of that county were there and made a search with no results and yet all officers are convinced that there were a total of 6 bodies and two are recovered and by the order of the JP these were sent to the Harris County morgue by ambulance and the JP was MARY DUGAT and conducted her investigation and then sent the bodies on to the morgue.

SEE SCENE DIAGRAMS...OF THE TWO SCENES WHERE THE BODIES RECOVERED BY DET BAKER AND ATTACHED TO THIS REPORT.

The defs were taken back to Houston and Pasadena and placed back into jail and will be marked hold for HOUSTON HOMICIDE, SHERIFFS IN: CHAMBERS COUNTY, GALVESTON COUNTY, JEFFERSON COUNTY, PASADENA PD.

Also, going back to the scene in San Augustine County, there were two slate type covers found on the grave sites there and Sheriff Hoyt held these for evidence.

Officers all returned to Houston with the search for bodies to be continued next Monday on High Island.

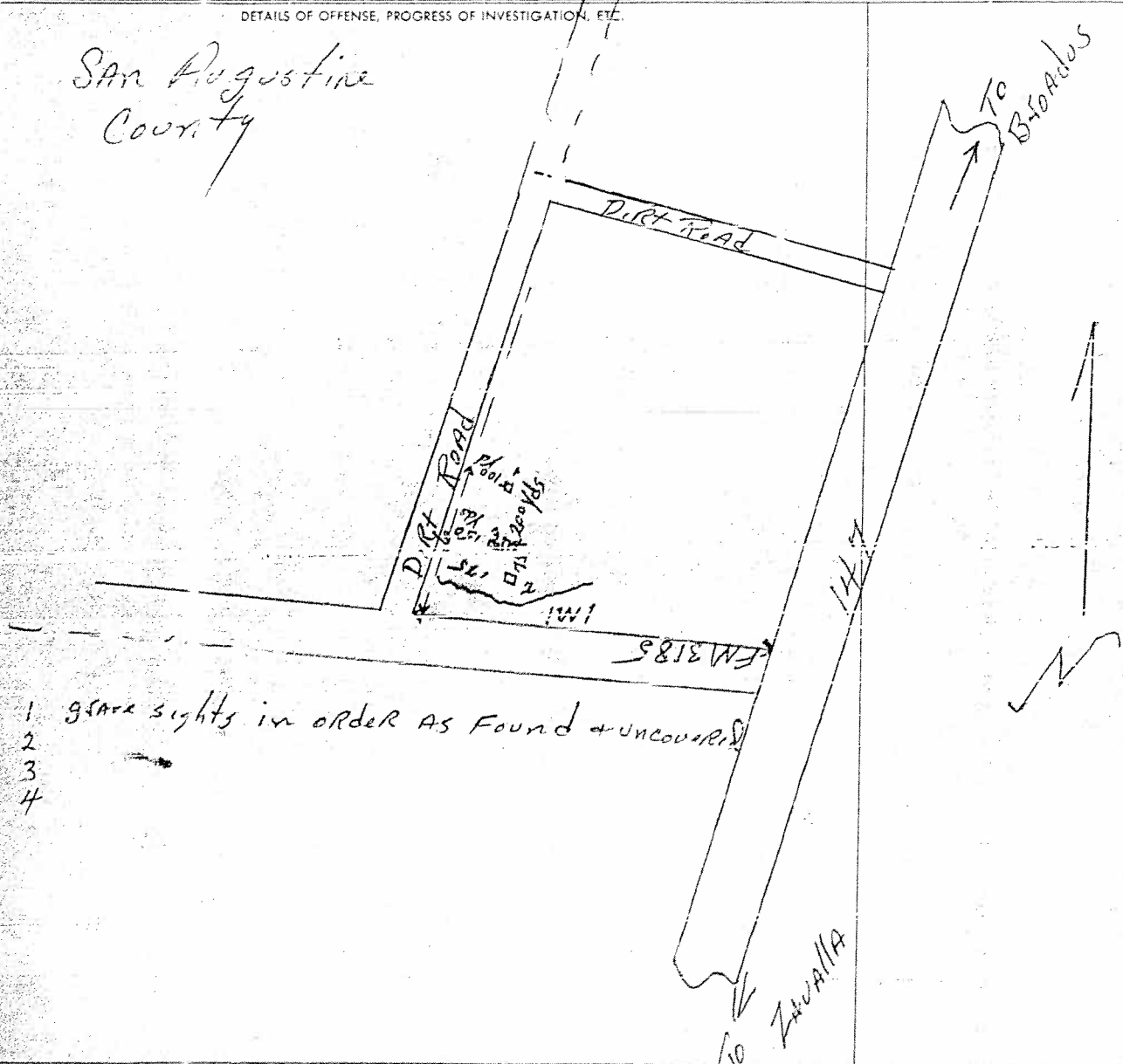

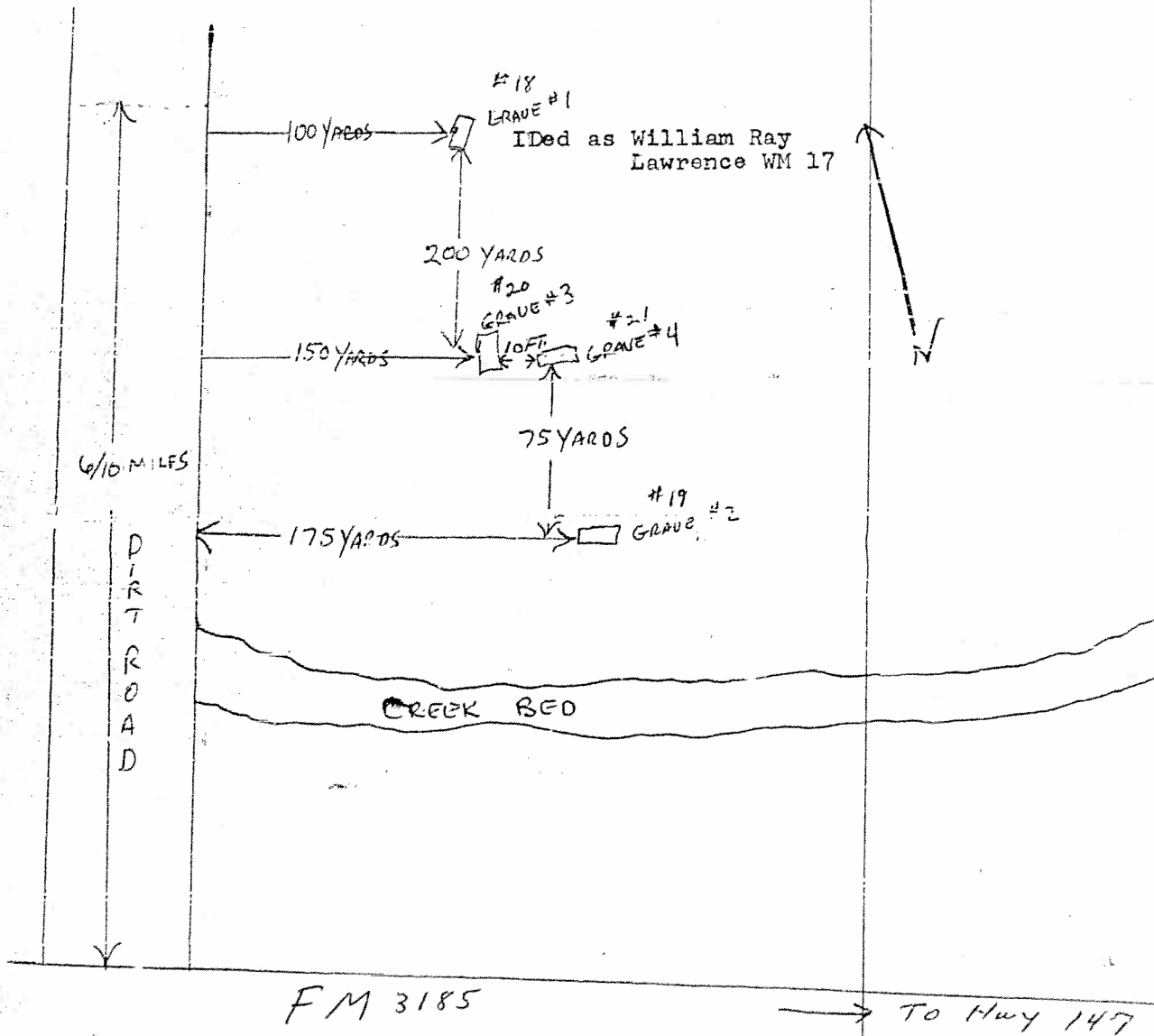

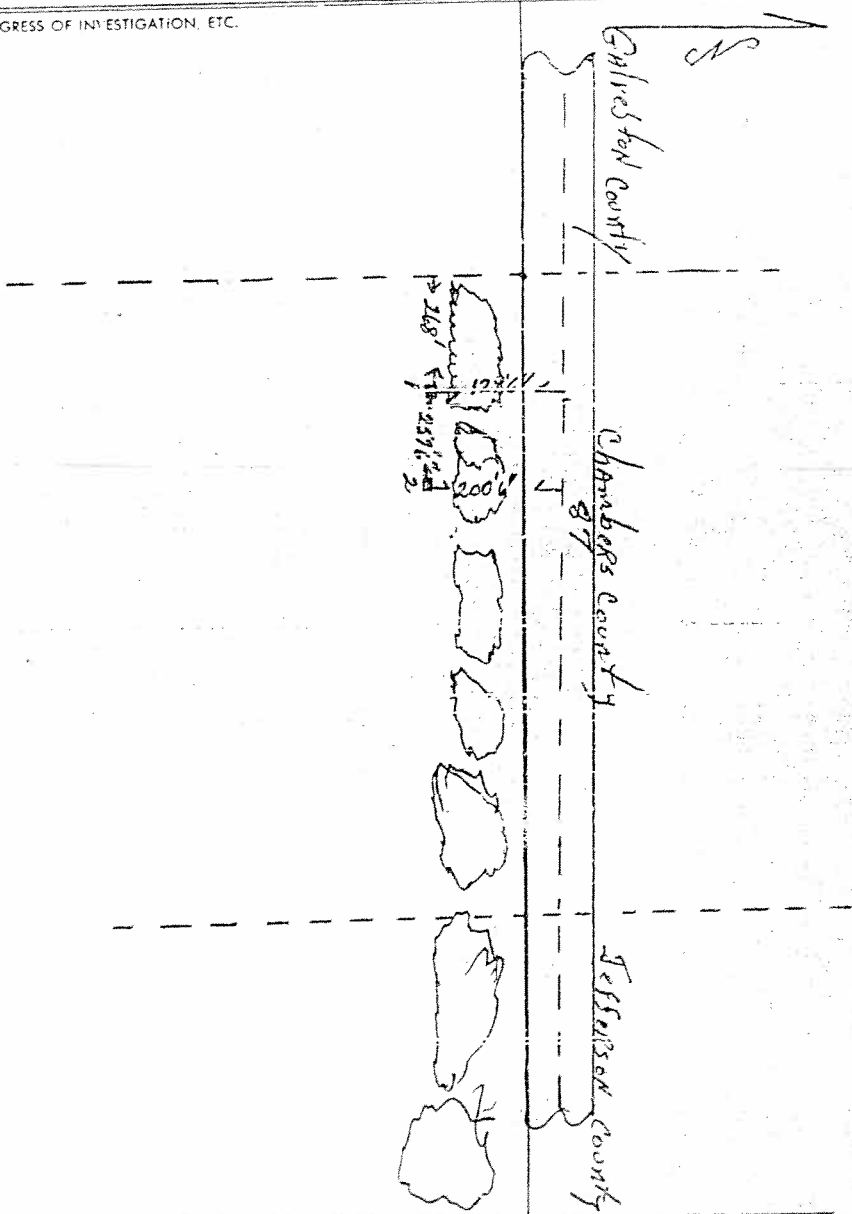

We, Tucker and Hamel, checked David Brooks out of the 5th floor jail at approx 7:30AM on this date. He was brought to the homicide office and talked to by Det. Tucker. This subject orally admitted that he had been involved in many murders with Wayne Henly and Dean Corlly to the extent that he was present when the murders were committed and he ~~was~~ helped bury many of the bodys. He was asked if he would reduce this to writing and he stated that he would but he wanted to wait till his father was present to sign this confession. He did make a confession which was finished at 10:30AM.

AT the time that this finished this confession Det. Tucker went to Lt. Belchers office in the Criminal Intelligence Office, and at that location he found both the defendants uncle and his father. The defendants father was brought to the homicide office and allowed to talk to his son. He requested that his brother be brought to the homicide office also and he was brought from Lt. Belchers office and he also was placed in the room with this defendant and Mr. Brooks. A short time later Det. Tucker was called into the office and the defendant stated that he was ready to sign his confession and at that time he signed the confession and this was witnessed by both his father and his uncle. For details see this statement.

The defendant stated that he would direct officers to the location on High Island where a body was buried. He stated that this location had been pointed out by Dean Corll to him.

We left the Homicide office at approx 11:30AM enroute to High Island Texas and arrived at that location at approx 12:45PM. Upon arrival at that location we were met by Det. Young, Baker, Paulk, Porter, James and Newman of the Homicide division, and Dets. Mulligan and Smith of Pasadena, who had Henley in custody. We were also met by Sheriff Lewis B. Otter of Chambers County and some of his personnel, and J.B. Cline of Galveston County and his personnel. We also had Charlie Neel of the Texas Rangers meet at that location.

At this point we proceeded upon the directions given to us by David Brooks to Hwy. 87 and then east for several miles until we came to a change in the color of the asphalt and at this time Brooks told us to stop. Brooks then lead us across a grass field to the beach and we then immediately came to a piece of broken concrete at the edge of the beach and the grass field and Brooks pointed this out as the place that one of the bodies would be buried. We began to dig at this area and approx. 1 foot below the surface we discovered what looked to be lime. We continued to dig deeper and then we found a decomposed body wrapped in a plastic sheet in this location. The other above mentioned officers had followed us to this location and after we discovered this first body the other suspect, Elmer Wayne Henley, Jr., lead a group of

officers approx. 75 yards east of this first location and pointed out a location where he believed a body was buried by himself and Dean Corll. This location was then dug up and the remains of a body was discovered. This body was also badly decomposed and it should be noted that the skull of the body had long dark hair. A ditch digger and a bulldozer arrived at the scene and other locations pointed out by the suspect, Henley, were dug up but no other bodies were found. Henley was trying to point out other locations where he and Corll had buried bodies in this area but he stated that it had been approx. one year since they had buried one in this area and that it was always at night and the area looked different to him at this time. Both Brooks and Henley had told us that there would be 5 or 6 bodies they had buried in this area. After several hours of digging in different locations along this site Sheriff Lewis Otter decided to stop the operations at this time and stated that it would begin again Monday morning. It now appears that there will be several miles of beach area that will have to be covered in trying to locate the other bodies. At the scene J.P. Mary Dugat, Box 332, Winnie, Texas (295-4041) arrived and conducted the preliminary inquest on the bodies that had been dug up and she ordered that the remains be transported to the Harris County Morgue by Sterling Furneal Home ambulance, which was driven by Jim Sterling. Photographs of the recovery of the above mentioned bodies were taken by Det. Tucker and also by Deputy J.A. Hawkins of the Galveston Sheriff's Office.

David Brooks was then brought back to the Houston Police Jail by Dets. Paulk and Porter and returned to his cell. The digging operations at this location were stopped this date at approx. 4:30PM.

This information was supposed to be coming from a WM by the name of Scott Brinks who lives in # 82 at the same location. This Brinks gave the info to the asst manager of the apartments by the name of Mozelle Copeland WF # 133, 461-8813.

We went to 1855 Wirt and talked to Mozelle Copeland and she related the above story but she said she was getting her information from this Scott Brinks and Scott was afraid of these people and was leaving.

We were unable to get in touch with Scott Brinks so we went to # 29 but no one was there. We then went to the washateria in the apt. project and found Tony Ashinsky and we then talked to Tony. Tony then invited us to his apartment (# 29) and showed us around.

The apartment was in shambles. Paper all over the floor, a mattress on the floor. There is an upstairs bedroom for this apartment and we went up and found this bedroom to be in the same shape. Tony told us that his apartment had been burglarized while he was in Jail.

It seems that the harris county sheriffs department had a warrant (narco) to run on this Tony and they did find some LSD and Marj.

They took tony in and also his room mate Craig Allen Brooks (WM)(17) and charged them with the above offenses. While the sheriffs dept was in the apartment they picked up some play hand cuffs and thumb cuffs. The officers kept this Note This took place before the mass murders were discovered. This Tony admits being Queer and is living with the young white male Craig Brooks. He states that he never knew any Dean Corll in his life and did not know anything about the murders until he got out of jail. Friday.

The chain of coincidents which led to this investigation is:

FOLLOWUP INVESTIGATION: 8-11-73

Dr. Jachimczyk called the homicide office and advised that the clothing taken from the storage shed recovered near bodies number #9 & 10 were positively identified by the parents of the Waldrop brothers, who had come to Houston from Atlanta, Ga., this morning, when they read about the killing of their sons in the ATLANTA JOURNAL THIS A.M. The doctor stated that #9 has been identified as being DONALD WALDROP and #10 as JERRY WALDROP. Dr. Joe reported both died of strangulation.

I was also contacted by Mr. Dreyamalla who wanted to know if his son has been positively identified at this time, which he has not. He then asked could he send a neighbor down with a better picture of his son and that it be shown to Brooks for ID.

A close up of the picture of JAMES STANTON DREYMALLA (WM)(14) was brought to this detective and then shown to David Brooks who stated that he thought this was the last person he saw to be at the home of Dean Corll about a week to 10 days ago. According to Mr. Dreyamalla his son was alive on the 4th of August according to his girlfriend who stated he was in the Montrose area. Brooks would not admit to having any knowledge of the killing but said that Dean picked the boy up by himself. This information was given to Mr. Dreyamalla.

The stepfather of JOHNNY DELOME (WM)(16) who was reported missing with or about the same time as BILLY BALUSCH (sp) Mother's Day last year, Mr. Gerald Oncale, 1447 Tulane, phone: 869-4247, brought several snapshots of his stepson, in order that they be shown to Mr. Oncale, another disgruntled parent who was upset at reading about details of his wife's son's death in the HOUSTON POST, wanted the pictures shown to David Brooks who stated that he knew for a fact it was Johnny Delome that Wayne Henley shot in the head in the house on SCHULER last year.

Mr. Brooks came to the station to talk with his son, to try and persuade him to help police as much as he could so that all the bodies he had knowledge of could be located and possibly identified so that other anxious parents would know one way or another that their son was no longer alive.

I checked David Brooks out of the jail and brought him to a separate office for a visit with his father and then handed him the snapshots Mr. Oncale had given me of his stepson, Johnny Delome, and without much reservation Brooks stated that they all looked like pictures of JOHNNY DELOME, and that he was the one that Wayne Henley shot in the head with a .25 automatic pistol.
