PROGRESS REPORT: 8-12-73

Tonight around 7:30PM, Bonds received a phone call from a WF who would identify herself only as the aunt of GERALD KAY MC DANIELS. She stated that McDaniel is a friend of Corill, Henley, and Brooks. That he has known Corill for about 3 or 4 years and has brought him to his home. Also that Brooks and Henley had been to his home and Brooks had on occasion spent the night with McDaniel. She further stated that we should ask Brooks and Henley about any bodies at Freeport as they often went there, also Galveston. Mc Daniels had a station wagon with curtains on all the back windows that all of them used to go to the beach in.

McDaniel has lived with his grand-father, G.F. McDaniel, 436 W. 23rd, until the last month or so. He is now living with his uncle in Channelview, Tex., at 14935 Lawther Dr., 452-4101. This aunt had a very bad opinion of her nephew and stated that the entire family felt that he is involved in this mess.

I checked ID and found that he had a record: HPD# 166-140, JERAL GAY MC DANIEL, WM(DOB 9-2-51). It is attached to this supplement.

QUESTER DOBIE, 6323 Goforth, 747-8670, the uncle of Charles Cobble WML7, one of the compl. in this case, had some information to add. He had help us in the missing person report on Cobble, D-31192, and early in the report he had talked to RHONDA WILLIAMS, at her apt. about Cobble and who some of his friends were. He said that she named Wayne Henly but said nothing bad about him. He was mostly thinking about possible enemies of Cobble and Marty Jones. He further stated that DAVID BROOKS WAS at Rhonda's apt. while he was there. This will have been on 7-29-73 or 7-30-73.

SHIRLEY DOLLENS, 304 W.27th #16, 862-3890. She is the last person to see Jones and Cobble at their apts. on 7-25-73, around 10:00PM. She was setting by the apt. pool alone when she saw them walking through the apt. unit with another WM. She described this other WM as follows: WM 18-20, 5'10", 140lbs., collar length dark brown hair, moustache. This description fits Wayne Henley. She is listed as a witness in the missing persons report, is out of town at this time, and will be back on 8-18-73.

Also on the night of 7-26-73, Cobble and Jones both called their fathers and told them they were in trouble and needed \$1000. each right away. That was the last that anyone heard from them. Cobble also told his dad that he could get in touch with MR. ROGERS, that he could help. None of the family knew a Mr. Rogers. Chester Dobie has been trying to find out who this Rogers is and has found out that he might be a dope dealer that is known to the youths in the Heights as "THE SPEED KING OF THE EAST END". No one has connected Cobble or ~~Ray~~ Jones with this Mr. Rogers. Dobie has not been able to find out his real or full name. Dobie has spread the word all over town that he wants Rogers to contact him. Last week, while he was in front of the Caviler Club, on Canal, a LAM in an old modle pick*up swerved to the wrong side of the street where Dobie was standing and Dobie had to jump to the hood of his car to avoid being hit. Three or four nights ago Dobie was outside the Harbor KI Lights Club, on McCarty, late at night, when he heard a gunshot. He thinks he was shot at. He has been told by several people he has talked with that he should lay off, that Rogers didn't want to have any thing to do with him. We advised Dobie to quit asking so many question for the time being.

Dobie has been told by a WM 17 that JOHN HARMON WML5, has been missing for about 2 years. He stated that his parents also received a call similar to Cobble's call, that he was in trouble and needed \$500. right away. They never heard from him again. We checked Missing persons and our compl. file and could find nothing by this name. Harmon was supposedly living at the Westcott Apts., Washington at Westcott when he dissapeared.

AUGUST 12, 1973.....9:15 P.M.

Det Spurlock was in the homicide office when Attorney Stuart Kinard came to the homicide office and stated that he had been talking to the mother of the suspect DAVID BROOKS, and the mother had asked him (KINARD) to talk to her son. The mother was in Louisiana. At this same time I received a call from MIKE HINTON, ASSISTANT DA, and he stated that he wanted this Det to talk to the suspect, DAVID BROOKS, and ask him if he wanted to talk to the ATTORNEY, KINARD. Det Spurlock then went to the 5th floor of the city jail and checked the prisoner BROOKS out of the jail at 9:35 P.M. I talked to him in the visitors room on the 5th floor, and there I asked him if he wanted to talk to the ATTORNEY, KINARD. I told him that KINARD had stated that BROOKS mother had called from LOUISIANA and asked him to talk to the suspect.

At this time BROOKS told Det Spurlock that he would talk to ATTORNEY KINARD, and he would be able to tell if he, (KINARD) had indeed talked to his mother in Louisiana.

Det Spurlock then returned to the homicide office where I advised Mr KINARD what the suspect BROOKS had told me. At this time, 9:40 P.M. I went back to the 5th floor along with MR KINARD, and I was present in the visitors room when MR KINARD and the suspect DAVID BROOKS talked. DAVID BROOKS talked to MR KINARD, then advised him that he wanted to talk to his father first, before he decided on any attorney. MR KINARD then asked BROOKS if he would do what his father advised, and the suspect stated that he would.

The suspect, BROOKS was then returned to the city jail at 9:50 P.M.

Mr KINARD and Det Spurlock obtained the phone number of the suspects father from the suspect, and when we arrived back in the homicide office MR KINARD immediately called the number given to us by the suspect BROOKS. After this phone call MR KINARD advised Det Spurlock that he had talked to MR BROOKS, and that he had told him (KINARD) that he already had retained an attorney, and did not want him (KINARD) to see his son. After advising me of this MR KINARD then left the homicide office.

I then advised MIKE HINTON of the above and he advised me to make this supplement.

PROGRESS REPORT:

On 8-9-73, we, Baker, Young, Paulk and Porter, were in the Homicide office and at approximately 3:15 P.M. we received instructions from Lt. B. Porter to accompany the Pasadena Police officers, Mulligan and Smith to Sam Raburn Reservoir where other bodies in this case were suppose to be located. We left the office and continued to Lusk, Texas, where we met Texas Rangers, W. W. CLARK and CHARLES A. NEEL. We all then continued to Sam Raburn by way of Zavalla, Texas and after crossing the bridge which crosses Sam Raburn, between Zavalla and Broadus, Texas we met the sheriff of Sam Augustine County, John Hoyt. After meeting the sheriff we continued to Sam Raburn. At first we passed the location and then turned a round and came back. We learned that the location was just north east of Jackson Hill Park. The arrested suspect, Wayne Hendley directed us to a location which is three miles north west of Broadus, Texas and one and two tenths miles west of highway 147. We turned west from 147 for one mile to where a dirt road intersected farm to market road 3185. We then turned north on this dirt road and went six tenths miles to where Henley stated that he thought this was the location. We stopped at this location and Henly directed us to the woods on the east side of this dirt road. Approximately one hundred yards east of the dirt road Henley stated that he had found the spot where one of the bodya were found, there was a spot or clearing of about fifteen feet between trees and there were some limbs laying over the spot where Hendley stated that they had burried one of the subjects at this location. He stated that there were two buried at this location, however after digging there only one body was found. He then stated that there were suppost to have been two bodies at this location and since there were only one he did not know who this might have been. ~~Hendley stated that~~ After digging this one it was learned that he had been buried some three feet deep and was lying in a fetal position and the head was to the east and trunk and feet portion to the west. The body was wrapped in plastic and had been tied or rapped with gray tape around the upper portion of the body and the lower portion. This body will be #1 on Chart.

While the first body was being dug up Hendley then directed us approximately two hundred yards south of this first body and about fifty yards north of a small gully and to another small clearing and some more limbs. He stated that this was where another body was located. This too was dug into and there was a second body in this grave and approximately three feet deep. This body also was wrapped in plastic and also had tape the head was to the south east and in a fetal position and body and feet to the north west. There was a board of masonite or what appeared to be masonite over this body. Hendley stated that they had returned to bury a nother one and that the animals had dug this one up and that they had placed a board over this one and had re buried it. This body will be listed as number two on the chart.

PROGRESS REPORT CONTINUED:

After digging the second body up it was late and dark at this location so we then ~~returned~~ went to the San Augustine County Sheriff's office where the arrested suspect, Wayne Hendley, was then placed in the county jail and was to return to the above location the next morning, Friday August, 10.

At approximately 7:30 A.M. August 10, 1973, we all then returned to the location near Jam Raburn where Hendley directed us to another location. This being approximately one hundred and fifty yards east of the above mentioned dirt road and about seventy five yards north of the second body. Hendley stated that this was where the two bodies would be found. After digging in these locations it was learned that the third body was also in a fetal position and the head was to the east and also wrapped in plastic as the other two bodies had been and approximately the same depth. Three feet to the north of the third body there was another body and this was also in the same position and was wrapped in the same manner. The head of this one was to the north. After the fourth body was found the arrested suspect stated that this was all that he knew of which was buried at this location but he stated that he could direct us to some more bodies which had been buried on the beach in High Islands, Texas.

After leaving the Jam Raburn reservoir at approximately 9:00 A.M. we then continued to Broadus, Texas and while at this location we learned that Sheriff Hoyt had filed two counts of Murder against this suspect in the early A.M. this was before we had arrived at the county So. We also learned that the Sheriff had recovered the boards which was over some of the bodies. All of the above bodies had some lime over the bodies.

The San Augustine county Sheriff had photographs taken at the scene and we will be able to obtain these if need be from him also there will be a report made by the So there and we will be able to obtain a copy of this if it is needed. The sheriff had the bodies removed to Lufkin for autopsies and for identification purposes and as of this writing it is our understanding that they will be moved to Harris County morgue from that location.

We, Pasadent police officers, Mulligan, Smith and Houston Homicide, Baker, Young, Paulk, Porter and Texas Ranger Charles A. Neel left Broadus Texas. Neel had gone on before these officers left and were to meet us in Lufkin. We then continued from Lufkin Texas to High Island and we met with Sheriff J. B. CLINE of Galveston County. After arriving on the beach we met Sheriff Louis Otter of Chambers county, and Richard Culberson of Jefferson County, and Capt. G. W. Woods of Jefferson County.

Also while enroute to the beach we met Det. Ned Newman and James who had several trustees for digging purposes, also we met Det Jack Hamel and James Tucker who had brought another arrested subject David Brooks to the beach.

Brooks
After arriving at the beach Hendley had the officers to drive a ways down the beach and then came back to a rock which was located two hundred and sixty eight feet east of the Galveston county line into Chambers county and 129 1/2 feet south of highway 87 which runs along the beach. At this location the rock was moved and a body was dug up at this location. At this time Hendley then directed officers to a spot approximately 257 1/2 feet east of this first body and 200 1/2 feet south of the center line of highway 87 where a second body was found. This also being in Chambers county. Then Hendley directed us to a spot which is approximately two miles east of this second body and in Jefferson county and stated that he remembered one more in this vicinity and he was going by a cedar break which was located in the grassy area between the beach and highway 87. He also stated that there was a grave with two more bodies in it between this location and the location of where the second body was found.

The bodies which were located at the beach was then sent to the Harris County morgue by Mary Dugat who is justice judge of Precinct number one of Chambers county.

This officer along with Deputy David Matlock and Chuck Mosley took the measurement at the scene and a diagram was by this officer using these measurements and a copy of this will be attached to this report.

Deputy Sheriff, Capt. G. W. Woods, stated that he had pictures and that if we needed any of these we would be able to get them. Also there was an areal photo taken according to Matlock and he stated that we would be able to get a copy of this.

This officer made a scene sketch of the area of Raburn and also of the beach and a copy of this will be attached to this report.

After we left the beach we then returned to the Homicide office.

Det's Porter and Paulk returned the suspect David Brooks from the beach at High Island and arrived at the Homicide Division at approximately 5 P.M. the 10th of August where Brooks was placed in an office in the Homicide Division. Brooks had requested that he be allowed to use the telephone. Det Porter remained most of the time in the room with Brooks and allowed Brooks to call first his wife, second his father, third his grandmother

We learned that he lives at 2121 Pech Rd apt 187, phone 468-6435 with his wife Rene. We went to that location and talked to Durst and advised him of the situation and asked him to come to the office for an interview. We brought he and his wife to the Homicide office and interviewed him regarding this offense and he denied any knowledge of the offense, but stated that he was friends with David Brooks and that he knew Wayne Henley and had associated with Dean Corll for 2 or 3 years. He stated that he did have parties at his house but stated that he had not procured anybody for Dean or anybody else.

He did state that he had suspicions that Brooks had killed a boy named RANDALL LEE HARVEY because it was his impression that Brooks thought that Harvey had stolen a stereo from Brooks. We checked with missing persons and found that a Randall Lee Harvey had been reported missing 3-11-71.

PROGRESS REPORT CONT: 8-13-73

I Carpenter contacted Frances Conley (work number) (862-~~9955~~) who stated that she has not heard from her son since he has been reported missing. She stated that he had dental work done by a Dr Sucler. I checked the yellow pages and found a Dr Chausse 8561 Long Point 468-7676. I recontacted Frances Conley who stated that this is the right Dr due to the adress. I called the Dr's office and asked if they had any dental records of Harvey and she stated that she would have to look at her old files and call us back, I asked her to have Dr Chausse call Dr Green at the morgue. In continuing this investigation, DALLAS PD was called and asked about the possibility of a murder in that city that was known about by CORLL and possibly BROOKS. Det Tucker called Dallas and Lt. Baker there called this AM and Young told him that TUCKER WOULD CALL him when possible and this information was called into DPS and they were to call CHARLIE NEEL and have him tell TUCKER ABOUT THIS. There is a possibility that one or more murders did happen and BROOKS is to have said that CORALL talked to someone there in DALLAS and they would compare notes as to how many they had killed. It was also mentioned that CORLL was supposed to be thinking of moving to Dallas soon.

On this date Dets. Mulligan and Smith, came to the Homicide office and after talking to these detectives it was learned that the arrested suspect, Hendley, had that the identification as to the subjects in the grave sights as mentioned in previous supplement and as drawn on the scene sketch are as follows;

In the first grave sight which was numbered as they were dug up as number one grave Hendley stated that he did not know who this was.

In grave sight number two was William Ray Lawrence (WM)(15) this was according to Hendley's identification.

In grave sight number three according to Hendley would have been Michael Anthony Baulch (WM)(18). Checked with the Juvenile division and learned that there had been a wanted for felony theft however unable to locate a missing person report on this subject.

In grave sight number four it was learned that Homer Garcia was suppose to have been buried there. We do show a missing person report on this subject dated 7-1873.

After typing the above on Michael Anthony Baulch it was learned that this subject had been reported as missing and date on this was 9-5-72.

Also after going to High Islands and being showed where the graves there were located it was learned from Hendley that the first grave there would have been Ruben Haney, this would have been Ruben Williford Watson. Missing person report dated 10-17-70.

After Mrs Baulch left the homicide office I spoke to Det. Earls who said that he had brought DAVID O BROOKS to the homicide office to speak to his parents and had brought him from the jail at 12:00 on.

BROOKS was sitting in a office in the homicide division with his parents. at 1:10PM. this officer and Det Earls and Det. D. Fultz walked into the small office where BROOKS was with his parents. We asked David BROOKS to look at the pictures of BILLY and MICHAEL BAULCH to see if they were the two boys that had been mentioned earlier as having been killed. DAVID looked at his father and his father told DAVID to tell us if these boys had been killed. Officer Donovan showed DAVID a color picture of BILLY and DAVID said that he had been killed. He then looked at a picture of ~~BILLY~~ MICHAEL and he said that he had also been killed. He would not say where they were buried or how they were killed or who killed them. He was shown the letter and he said that he knew nothing about it. Officers left the subject with his parents and Det. EARLS returned DAVID BROOKS to the City Jail at 1:30PM.

COPIES of the pictures that had been given this officer were made in ID and these pictures along with the X-ray were sent to Mr. Holman Gregory of the Medical Examiners office along with the physical description that was given over the phone by this officer. The pictures were sent by Patrol unit 762 Officers E.E. BEMMINGFIELD 1389 and A.J. TOEPOEL 2204 at 2:30PM. A copy of the letter was made and retained by this office and is attached to the report. The original pictures and the letters was returned to MRS Baulch this date by mail.

This officer had asked MRS BAULCH if missing persons reports had been made on her two sons. She stated yes but officer was unable to locate a report on BILLY in missing persons. A report was found dated 9/5/72. Report stated that MICHAEL had been missing since 8/21/72.

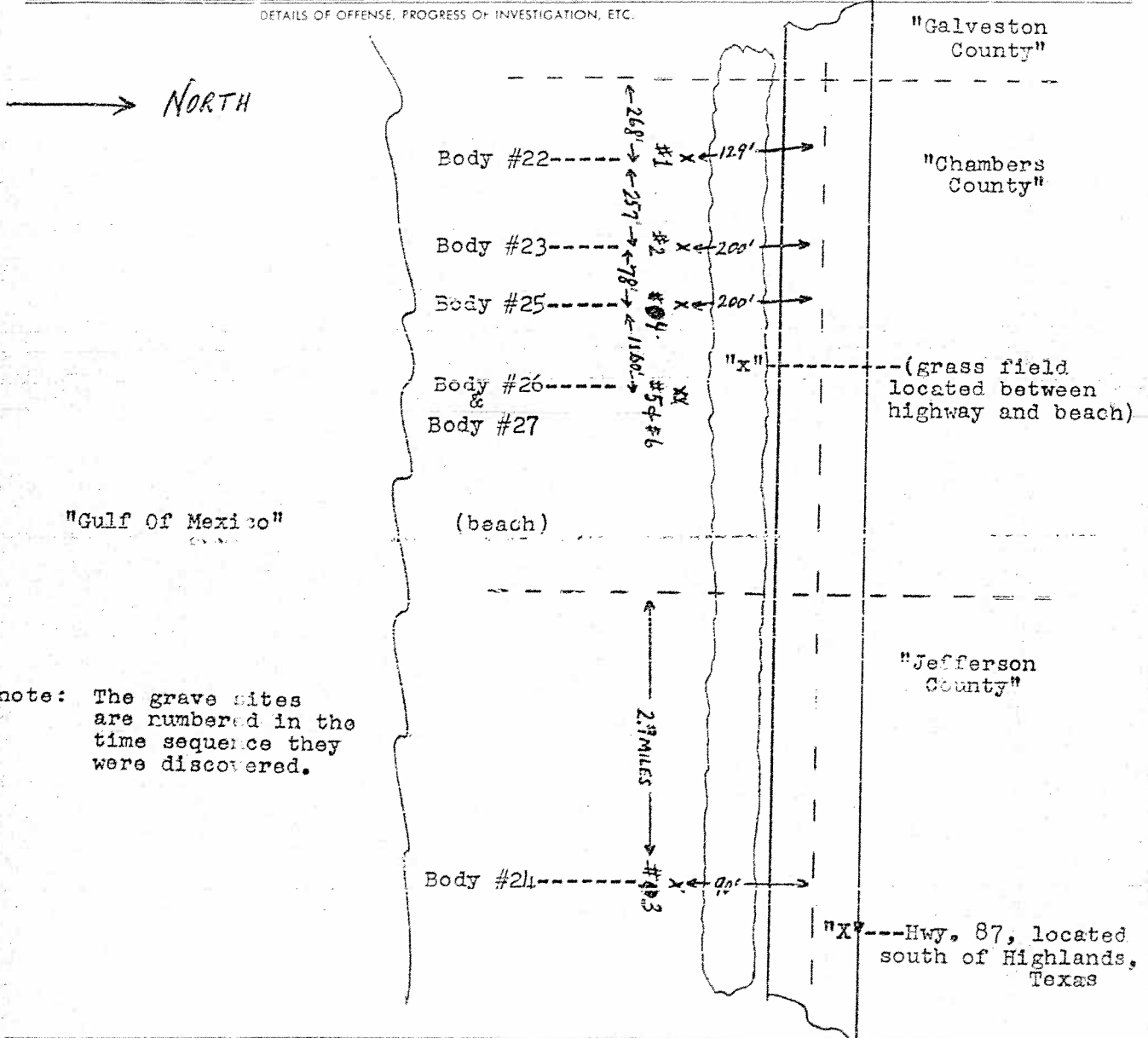

We requested the Police Photographer Mr Hare to go to the residence of Dean Corll's parents at 4519 N. Crooked Cree~~k~~ and take pictures of the van truck belonging to Dean. I went to this address and talked to Mr and Mrs Arnold Corll at their request who told me that they felt that Brooks and Henley were telling lies about Dean to cover up for what they had done themselves. They said that Dean had been making plans to go to Colorado with his real Mother and brother. He was supposed to quit his job and had reportedly asked his girl friend Betty Hawkins Bus Phone 522-9859, Home phone 444-4929 to marry him and go with him to Colorado, the 1st of September. Mrs Corll showed me a calender at the home at 2020 LAMAR in Pasadena which had the 31st marked with a double circle around it. Mrs. Arnold Corll (Dean's stepmother) stated that she and Dean got along very well and that he had called her early this month and told her that he might have to leave town that there was some trouble. Dean had asked that Brooks be allowed to use their home near Sam Rayburn Lake for his honeymoon 2 or three weeks ago and that she had told him no and latter asked Dean about it and been told that their place hadn't been used. I requested that our lab be allowed to go over the panel truck and they stated that they would be glad for us to check it out. Arrangements were made for our lab to go to their address in the morning and check the truck. The Corll phone number is 941-8335 but they are going to request that it be changed to an unlisted number tomorrow because of all the crank phone #####. calls.

9:45AM: Dr. Jachimczyk called and stated that body number #11 died of GSW to head, .22 cal;

Body #12 also had a GSW to the head of .22 cal. and also provided the first evidence of sex mutilation; along with the remains of the body is a triple plastic baggie which was tied with its own material and contained an amputated penis and testes inside.

Dr. Jachimczyk also stated that they were able to obtain a good set of fingerprints of the #1 body which is possibly the last victim known to police: James Stanton Dreymla WM 13 and it was requested that an attempt be made to obtain some latent prints of the missing boy from some of his property. Mr. N. LeBlanc of the Identification Lab went to the parents of the Dreymla home, 5411 Laurel Creek, and obtained some latents and brought other items known to belong to the compl.

A patrol unit was sent to the morgue to pick up the prints of the #1 body and they were brought to the ID section for Mr. LeBlanc.

Mr. LeBlanc stated that the latents lifted at the Dreymla home will definitely not be those of the #1 body and that the other material treated with ninhydrin will have to dry before comparison can be made.

I also attempted to check with the morgue as it was indicated by Officers Massey and Knotts of the Juvenile Division that dental records of the Dreymla boy were taken to the morgue sometime on the 10th.

Body #1 has reddish hair instead of blond, and is about 5'11", 125 lbs., and possibly will not be the Dreymla boy. It is unknown at this time if his dental records have been compared, but the morgue does have the Dreymla dental records.
